1. Congratulations are in order for Dr. Rick Cobb on being chosen as the Oklahoma School Public Relations Association (OKSPRA) Administrator of the Year.
2. Congratulations also to Mr. David Peak on being named the South Oklahoma City Chamber of Commerce Administrator of the Year.
3. I am pleased to announce that several of our high school students received honors this past week: Kortney Bush of Moore High School was named the South Oklahoma City Chamber of Commerce Student of the Year and Calvin Miller of Westmoore High School received Honorable Mention. In addition, Julia Olstad of Westmoore High School received the Student of the South from the Women of the South Organization.
4. The South Oklahoma City Chamber of Commerce also presented Lindsay McDonald of Westmoore High School the award as Teacher of the Year Honorable Mention.
5. Congratulations to the student council of Westmoore High School on being named as one of the best student councils by the National Association of Student Councils. The award

is in recognition of maintaining strong year-around programs. The group will officially be recognized, along with others, at the National Student Council Conference in the summer in Albuquerque, New Mexico.

6. I am pleased to announce that Moore High School hosted the District 8 State Student Council Convention last week. I attended the opening ceremonies and was very impressed with the students, not only from Moore High School, but from all the schools that were represented.
7. Congratulations to Karen Blanden, 5th Grade U.S. History teacher at Broadmoore Elementary School on being selected as one of 25 Oklahoma teachers to be selected to attend the 2015 Summer Colonial Williamsburg teacher institute.
8. Grant Talkington of Brink Jr. High will represent the Sooner State next month at the national Geography Bee in Washington, D.C. ----- Grant won the state contest on March 27th in a tiebreaker round on the question, "What country includes the islands of Melville, Mornington, and Bathurst?" (The answer is Australia.)
9. Congratulations to the following Southmoore students who competed and placed at the FCCLA (Family, Career, and Community Leaders of America) State Competition last week: Lindsay Goetz, Interior Design – 1st place; Ciara Reichenberger, Career Investigation – 2nd place; Campbell Homen, Fashion Construction – 2nd place; Kierstean Lane, Cake Decorating – 2nd place (awarded a \$3500 scholarship to Auguste Escoffier School of Culinary Arts); Karmayle Richardson, Recycle and Redesign – 3rd place; and Alyssa Thomas, Children's Literature – 3rd place. Lindsay, Ciara, Campbell, and Kierstean will go on to compete at the national level in Washington, D.C. In addition, the Southmoore FCCLA submitted their chapter website to the National FCCLA and was one of only 15 schools nationally selected to compete at the National level. Kierstean Lane will give a presentation regarding how the website was developed as well as how the website was incorporated into the FCCLA program.
10. The Summer Food Program will be offered at the following sites from June 1st – 26th and July 6th – 24th this summer: Central, Winding Creek, Kelley, Plaza Towers, Santa Fe, and Kingsgate. Breakfast will be served from 8:30 – 9:45 a.m. and lunch will be served from 10:45 a.m. – 1:00 p.m.
11. We are thankful to Patrick Chase, Amy Simpson, Rick Cobb, and Michelle McNear for writing the appeal and winning the appeal from the State Department of Education relative to the A-F report card for Plaza Towers Elementary School.
12. The district will put a bond issue before the voters in early Fall. It will be the largest bond issue ever presented. The biggest item on the issue will be for funding tornado shelters at every site in the district (except, of course, for those sites who already have

one). The next Patrons' Advisory Committee meeting to work on the upcoming bond issue will be held the end of April or first of May.
